Our vision is to create a society where individuals with disabilities are empowered and included.


The mission focuses on providing comprehensive care and support services.

Feedback from participants indicated significant improvements in mobility and confidence.




Community Awareness Campaigns

Patient lives in a rural area of Isma - 2,Gulmi,with his family. They do household work and agriculture for their livelihood.

Patient the age of 5 he met with RTA(Road Traffic Accident) in which he had to undergo amputation of his left right through ankle.

So we had provided him artificial foot since 10 years. Now he has been studying in Grade 10. He travel about 2 hours from home to school by foot. Before he had faced many problems but after receiving the artificial foot it's been much easier for him to carry out his ADL'S. Now, the parents as well as the patients is very happy and grateful towards the service provided by HDC.

Challenges Faced

Despite our successes, we faced challenges such as limited funding and resources.

Accessibility issues in the community hindered some outreach efforts.

We also encountered stigmas that affected the participation of individuals.




Financial Overview

Funding was received from donations, grants, and community support.


We ensured transparency in financial management and reporting.
